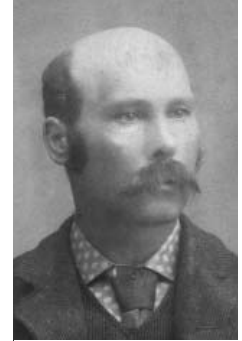

Johnathan #1 marriage was to Sarah Catharine RAGSDALE in 1849 in Osage Co. Missouri by the Revernd William _ampkins. She was 16 years old.

They had two children: one daughter b. 1844 and one son b. 1847 (names unkown)

According to the divorce papers, Sarah change as soon as she was in Oregon and became the party girl with transcient men according to Jonathan, On the 16 August 1856 she left Jonathan. Jonathan distract and angry internally (assumption) filed for divorced and it became final 14 Oct 1856.

further represents that he is thirty years of age. And
was lawfully married to one Sarah Catharine RAGSDALE
A.D. 1849 in the State of Missouri in Osage County by
our William _ampkins a Justice of the peace in and for
Lane County. And as your petitioner is informed and
hereby believes the said Sarah Catharine was then at
the time of our Said intermarriage sixteen years of
age and is now twenty three years of age. And from
the acquaintance your petitioner have with said Sarah
Catharine prior to our said intermarriage your
petitioner believe that the said Sarah Catharine would
make your petitioner a good industrious and
ajneable companion for life. But- shortly after your
petitioner and the said Sarah Catharine arrived in
Oregon Territory in the year 1851, The Said Sarah
Catharine became ill tempered and exceedingly cross
toward your petitioner, frequently using indecent
improper and abusive language to your petitioner. Such
as-"you're a worthless good for nothing lying puppy. I
wish you would leave me. I don't intend to live with
you any longer." "Rendering the life of your
petitioner burdensome," and your petitioner would
further represent that on the sixteenth day of August-
Last the said Sarah Catharine left the bed and board
of your petitioner-and giving the past winter and
summer the said
Sarah Catharine has frequently kept the company of
transient strange men at such times and places and in
such a manner as W-fully. Convince your petitioner
that the said Sarah Catharine is living an unvirtous
life and is untrue to her marriage vow with your
petitioner.

And your petitioner would futher represents that since
the intermarriage of your petitioner with the said

Sarah Catharine, the huz had two children, one a girl , now five years old, the other a boy and now two years old-and your petitioner would further pray this court to grant a divorce from the bonds of matrimony now existing between your petitioner and the said Sarah Catharine and that the dame may be completely dissolved and further that this Honorable court will make such dispostion of the children a foreseen as shall seem just and proper for their present and future happiness.

In the Book "Marriage Records Lane County Oregon 1852-1869 Compiled by Oregon Pioneer Research Bureau, 1991 Madison St. Eugene, OR. 97405 dated 1968.

This is on page 17. It states: "KEENEY, Jonathan and Mitchell, Margaret were married on 23 December 1858.

The witnesses to their marriage are Oliver H. MITCHELL and Martha C. MITCHELL.

The minister or elder performing the Ceremony is a man named Gillmore CALLESON

Then I have a copy from the "Oregon State Journal, Eugene City, Oregon, Saturday April 26, 1873 page 2 Col 5. Under Court Proceedings. It says Margaret Keeney vs Jonathan Keeney, Divorce, Granted

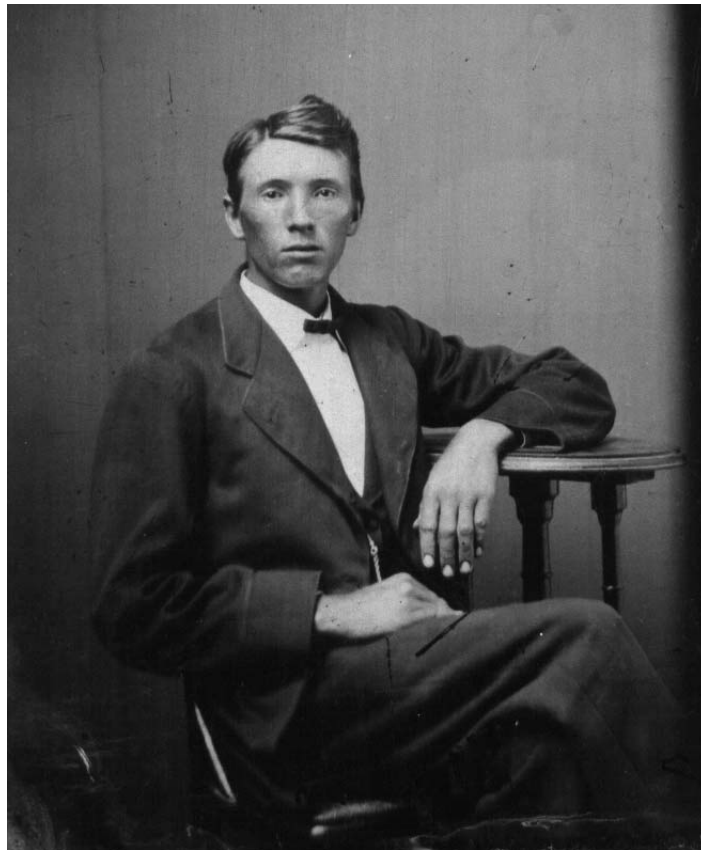

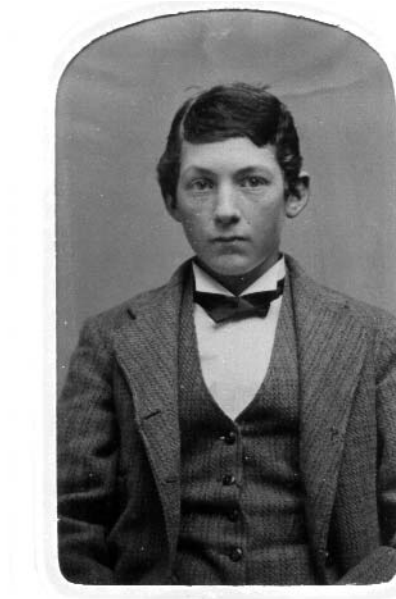

So he buried Oliver and Myrtle but failed to handle the purchasing of the headstones. Times were hard. Court Costs, expenses paying their bills. (I am trying to keep positive). The house was sold and \$\$\$ went to the two children. There is more info yet to be purchased from the public records. At two dollars the first page and one dollar there after, it adds up really fast. mind you I have had to start from scratch.

Vincent and Emma had a 1958 Chev and a small travel trailer which matched in color, Red and
white. They camped out alot and enjoyed themselves.
I have some pictures of some place in Mexico. They visit the local lakes, went to the ocean with all
of us, daughter: Virginia & husband George R. HOPEY,
Maria Verona HOPEY, mother of Georges. Rick and myself (Taryn) kids of Virginia and George R.

After Tommy died, Emma wanted to travel somewhere. She mentioned about seeing the family of
the NELSON's in Oregon or Calif. then spoke about seeing Mexico. Previous to her leaving I saw her
in her trailer and she took off her wedding ring and took the stuffed Monkey she had on her bed and
she sliced opened the back of the stuffed animal, took out the stuffing in one of the legs and placed
her wedding ring in the animal, restuffed it and hand stitched it back up. She left with her car & trailer
and off she went. I believe she earned her living while on the road in those states-by working as a
maid. (By this time she was in her early sixties.)

Emma came back and stayed with her son Donald J. FARRELL for a couple of years 1965-1967
aprox.) in her trailer and then came to live with us 1967-1969. She only brought her car with her
when living with us.
Donald lived in Spanaway and we lived in Rural Parkland (farm Land) on the western hilltop of the
Parkland area, about 7 - 10 miles apart from each other.

when I was told I would get to go see my grandmother, Emma, on the weekends, I would be so

very happy and excited to see her! With those 7-10 miles, it seemed like it took forever to get there at 35 miles an hour. When we would pull up to Dons home, Emma would step in her doorway of her trailer and step out by the time we got out of the car. I would run with arms wide open to give her a big hug!!!, Which she would gladly accept. Then we would go inside the trailer and she & I would play "GO FISH" for awhile and talk. Then she would play solitaire when I went inside to visit with my 1/2 cousins, Vincent & Tracy.

Emma owned her car & trailer but other than that, she barely had the basics in every aspect. As for Clothing-- A few smocks (tops) to wear and a couple changes of pants.

Every year for our birthdays she would give us a card with a \$1.00 bill in it. This would include Vincent & Tracy FARRELL, Rick HOPEY & myself.

When I was eleven yrs old I was having growing pains in my legs something awful when sleeping, it would wake me up. Emma and Virginia were sharing her bed. I awoke on the 19 January around 11 p.m. went downstairs and woke my mother up complaining about the legs. I wanted to squeeze in their bed and sleep with them that night but Emma insisted that she would sleep on the couch and I could sleep in the bed with my mother.

My mother woke up about 5:30 a.m. to have some coffee and speak with her mother before she went to work. Virginia discovered Emma on the couch. My mother told me later that day that she heard her, Emma, making a gasping sound in the middle of the night but she thought nothing of it at the time.

I felt so bad for coming down and waking them up and having Emma move to the couch. My mother would of called the ambulance if Emma was sleeping beside her that evening. Whats a 11 yr old suppose to think?

Emma died on my brothers birthday, 20 January 1969. My mother went to the lock box for her papers and discovered that she had birthday cards for both Rick and myself, which is in May for that yr. in there. (always thinking ahead of herself).

So here it was, my first experience in seeing death before my eyes, I was truly in SHOCK with all the things I had experienced that morning.

For about 3 months previously, she spoke of gastric upset, a burning sensation. The Coroner stated, She died of "hardening of the arteries."

George F. Keeney is a "Foreman" for the Company of " Nichols & Crothers" (William R. Nichols, Robert A. Crothers) their business was "Sash & Door Manufacturers, Builders & Contractors, Office 1350 South C. Factory E, 27th N.W. Corner of I. Tacoma, Wa.

George is a boarder located at 2516 South C St.

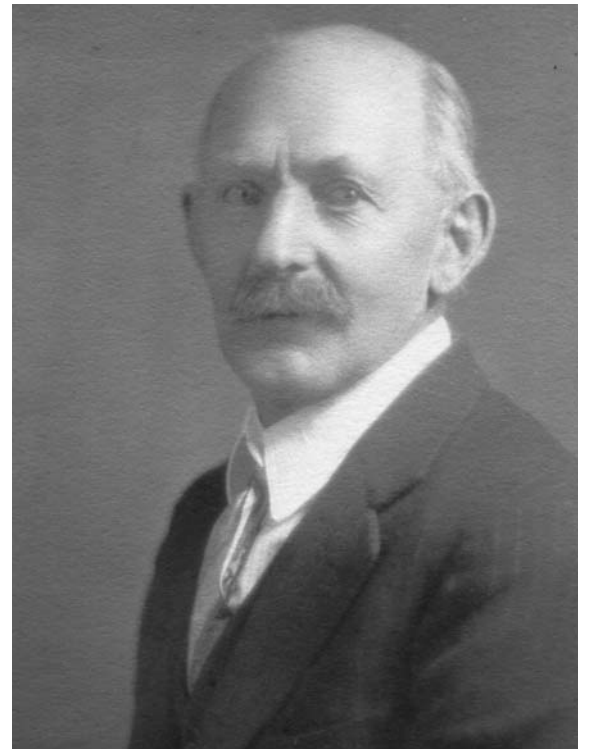
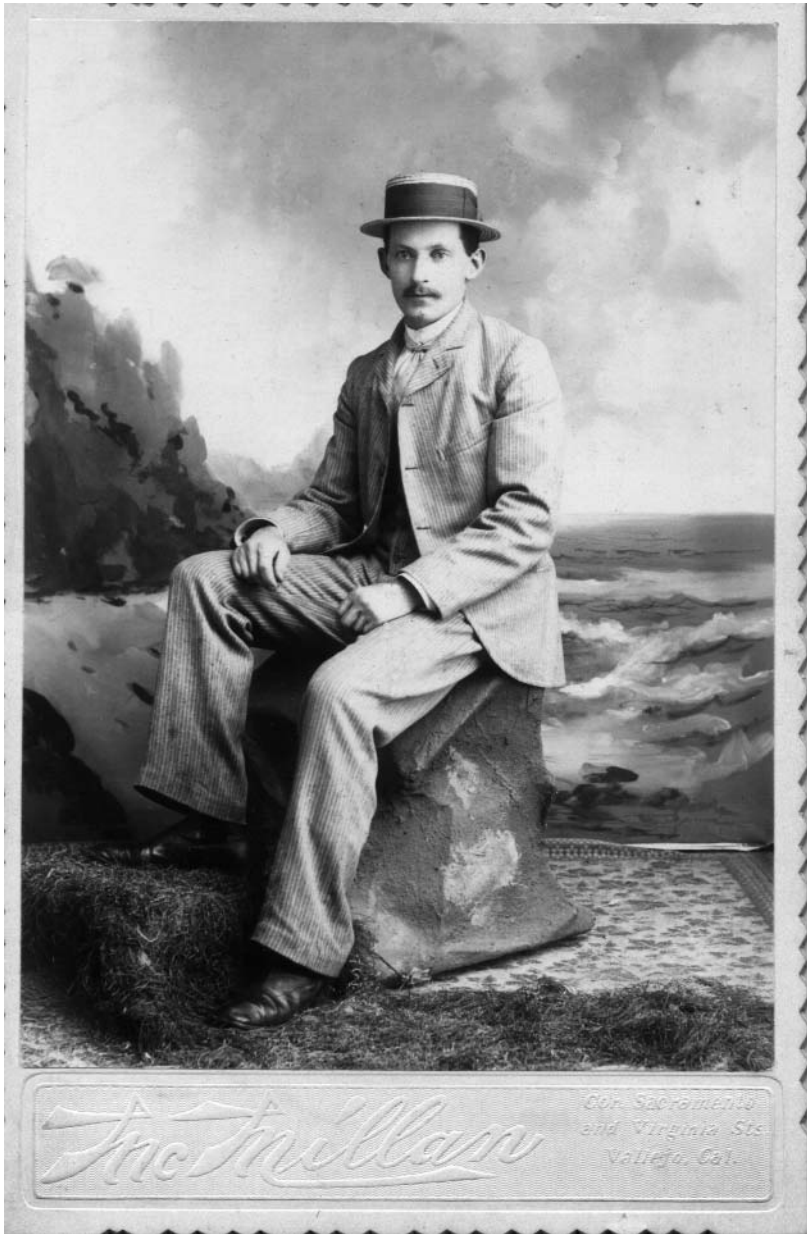
Martha Jane Keeney and her mother, Margaret Smith Mitchell Keeney lived in Portland after Jonathan and Margaret Keeney were divorced. Margaret took in laundry and Martha Jane, a teenager, worked as a housekeeper. Martha Jane became pregnant. So the family, who I guess knew the Cherry family from Eugene Oregon (David Cherry Furniture Company) and their 2nd furniture company in Eastern Washington -- since the Keeney's moved there later ... arranged that Martha Jane would be shipped by boat and train to Eastern Washington to marry Joseph Cherry who had agreed to marry her -- but did NOT agree to taking on her new baby. She had to give it up for adoption in Portland and then head to Eastern Washington, where Margaret Cherry was her first child by Joseph Cherry (b. 1851 Armagh Ireland).

I have a copy of that picture of Martha Jane Keeney Cherry with daughter Margaret, her first child by Joseph Cherry. My grandfather, George Cherry was the next living child. I think there was another son born in Eastern Washington , who died before they moved to Gig Harbor. Margaret Cherry married Marvin Coleman and moved to Portland. Martha Jane moved down to Portland after Joseph Cherry died, and after they had lost Cherry Point in Gig Harbor to the 1930s depression. My dad's cousin, Robert Keeney Crandall, son of Martha Josephine (Josie) Cherry, said Martha Jane Keeney was a wonderful grandmother. But my grandfather, George Cherry had a different experience. George Cherry is said to have reported his sister Josie's husband for welfare fraud when he refused to take a job that George had offered him. I guess George was furious that his sister's husband wouldn't work to feed his wife and children. Anyway, most of the family wrote of George Cherry (my grandfather) at that time. The kids (Robert Keeney Crandall, Margaret Crandall Chessum and my dad, Joseph Sidney Cherry) were all in a one room school house in Rosedale and Robert Crandall would not speak to my dad at school all those years because of it. George's own mother did not speak to her son George again for the rest of her life. My dad claims that it was a neighbor down the street who turned in Walter Crandall it is very sad that a family does not speak.

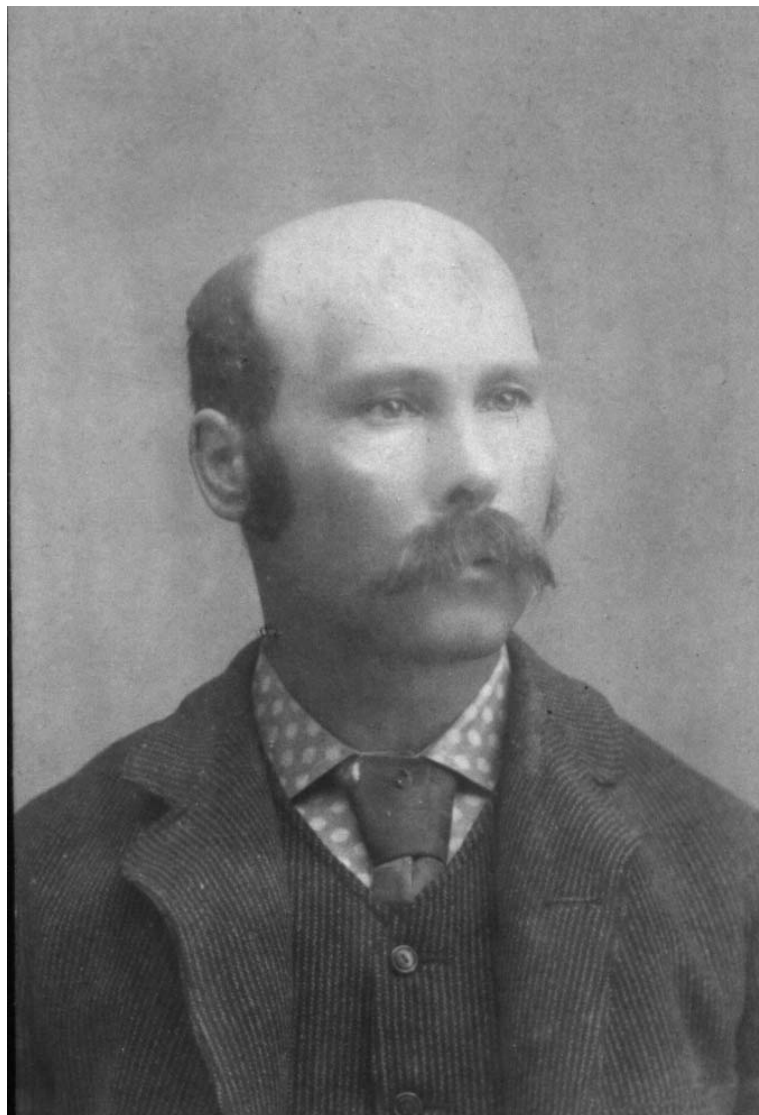

ELIJAH N. KEENEY is one of the principal owners of the town site of Eugene, which postoffice is known as Gifford. He has always been public spirited and generous for the upbuilding of the town and surrounding country. He has donated lots to several worthy purposes and is always on the progressive side of things.

Elijah N. Keeney was born in Eugene, Oregon, on November 12, 1866, being the son of Jonathan and Margaret S. (Mitchell) Keeney. When our subject was ten, the father went to Colfax, Washington, and his sons joined him three years later. The mother died April 14, 1899. Elijah worked in the planing mill business in Colfax for eight years and in 1892, went to Valejo, California, where he labored for three years as an undertaker for Henry Connolly. In August 1895, he returned to Colfax, and later came to the reservation, securing the claim where he now lives. He built a primitive log cabin and for a long time it was used for the meeting place of the settlers. He has improved his place in excellent shape and raises the cereals, handles stock and has some registered specimens. A portion of his land has been used for the town site of Eugene and many have purchased lots from him. Mr. Keeney has three brothers, Oliver M., George F., and John J., the last two living in the vicinity of Rosedale, Washington, and the former in Whitman county. He has one sister, Martha J., wife of Joseph Cherry of Rosedale, Washington.

On May 23, 1900, Mr. Keeney married Miss Eugenia, daughter of John and Catherine M. (Thiele) Allen, natives respectively of Arkansas and Missouri. They reside near Drain, Oregon, having crossed the plains in 1852. Mrs. Keeney's ancestors on her mother's side came from Germany and her paternal ancestors from Tennessee. She has four brothers and one sister, Robert L., Frederick A., Murry M., Creed H., all in Oregon. The sister, Mrs. Susie E. Hanson, lives near our subject. Mr. Keeney has a membership in the M. W. A., Melrose Camp, 6216. He was clerk of Beeman Camp, M. W. A., 6885, at Eugene until it disbanded. In politics he is independent. To Mr. and Mrs. Keeney there has been born one child, Hester W. Mr. Keeney's grandparents crossed the plains with ox carts in 1852, the maternal grandfather being from Maine and the maternal grandmother from Connecticut. Mr. Keeney has served as school director and has always labored for the advancement of the cause of education as well as for the general progress and he has universally shown himself a man of mature judgment and keen wisdom, while his integrity and intrinsic worth is never questioned.
